I do have my priorities, however, and have managed to put aside a somewhat overdue commitment to write the 1987 Venman Family Christmas Letter in order that the HBC membership be informed of upcoming goodies. As follows -

REGULAR MONTHLY MEETINGS

All meetings are at 7:30 p.m. at the Hitchcock Center unless otherwise noted.

On Monday, February 8, Tim Armstrong, a grad student in ornithology at UMass. will present a program on "Birds and Mammals of Kenya". We will begin promptly at 7:30 with a business meeting. The agenda will be a vote on the By-laws presented by the Board of Directors. I am enclosing a copy along with a brief letter of explanation. The Bylaws will not be read at the meeting. We ask that you read them far enough in advance so that you can contact one of the committee members if you have a question.

On Monday, March 14, Sheila Carrol and Mark Lynch will return to speak on "Birds of England and Scotland". As many of you will remember, they gave us a wonderful program on the birds of Eastern Australia last year. Both are experienced birders from the Worcester area. Mark is an instructor at the Worcester Art Museum and had a splendid article in the October '87 issue of Bird Observer about birding in Quabbin, Gate 40. I would be happy to lend a copy to anyone interested.

Monday, April 11: Carolyn Boardman on "Herons in Western Massachusetts".

Monday, May 9, David Spector on "Sweet, Sweet, Sweet, Sweeter than Sweet: The Life and Songs of the Yellow Warbler".

Monday, June 13, at 6:00 p.m., (note different time): Party/Potluck with a recap of the year and plans for the future.

FIELD TRIPS

Leaders ask that you call if you plan on going on the trip. This way, if there is a change of plans due to a rare bird someplace else or uncertain weather, etc., you can be contacted.

Saturday, February 6: Allan Richards will lead a trip to the South Shore. It will be leaving from the Hitchcock Center at 5:00 a.m.. Please call Allan at 665-2761.

Saturday, February 6: If the Coast is not your thing at this time, you might be interested in taking part in the Annual Winter Raptor Survey which is conducted in this area. If so, please give Scott Surner a call at 253-7486.

A <u>Cape Cod Weekend (Feb. 26-28)</u> is in the works. The plans are to go down after work on Friday, bird all day Saturday and much of Sunday, and return Sunday evening. The group will concentrate on large flocks of Razorbills, Northern Gannets, Kittiwakes and Sea Ducks. The motel is \$36.00 per night. Scott is in charge so if you are interested please contact him at 253-7486 no later that Feb. 20.

Plans for the Annual HBC Monheqan Island Memorial Day Weekend May 20-23 are also being formulated. Several people signed up at the January meeting, and since we are limited as to how many can go, it would be wise to call Scott at 253-7486 if you are interested in going or just want more information.

Also - Please remember to check the VOICE (253-2218) regularly for the recorded message. Not only will you learn what birds are in the area, but the VOICE is where you will learn about any field trips formed between Newsletters. Here is a copy of the HBC Bylaws to be considered for adoption on February 8, 1988. Aside from sprucing up the wording, it is essentially unchanged from the draft presented at the December meeting with the exception of the Article on Field Trips.

A BIT OF HISTORY

We on the Board of Directors decided to go this route when we became concerned about the liability of the Club should someone be injured during a Club activity. We live in a suit-crazy world, sadly enough, and we felt we needed to look at ways of protecting the Club, the field trip leaders and the Board members. (In some cases individuals have been known to sue the Board member with the most money simply because his/her name is there as someone in charge.)

A subcommittee was formed and concluded that being incorporated as a non-profit corporation would be a wise move. The first step in this process is to adopt a set of Bylaws for the organization. We started work last summer and presented a draft to you at the December meeting. We received some helpful suggestions which we acted upon.

We met with a lawyer in early January to go over the document and to get answers to our questions. One major concern was where we stood on the question of liability. He felt that the Bylaws covered everything necessary and made us feel considerably more comfortable concerning the liability question, especially as it applies to individual Board members. Two recently passed Massachusetts bills (M.G.L. Chapter 238 and M.G.L. Chapter 345, both of the Acts of 1987) make it difficult, if not impossible for individual officers, directors, and trustees of educational or charitable corporations to be sued because of injury sustained by an individual, unless gross negligence can be proved. The lawyer did feel that incorporating was important however, and our document paves the way.

AND SO -

We present this to you for a vote. It will <u>not</u> be read at the meeting and, as indicated in the meeting notice, we ask that you allow yourself enough time to read it so that if you have a question you can contact one of the committee members ahead of time.

Jim Marcum is Chair of the Committee. Members are Tom Arny, Magda Bechar, Nat Drake, Jan Ortiz, and Sally Venman.

We are well on our way! We are anxious to get out of the legalities and into the birdwatching, but we do feel this is very important to our future!

BYLAWS OF

HAMPSHIRE BIRD CLUB

AMHERST, MASSACHUSETTS 01002

(To be considered for adoption, February 8, 1988)

Article | - NAME

The name of the organization shall be Hampshire Bird Club, which will subsequently be referred to as the HBC in this document.

Article II - PURPOSE

- 2.1 The first purpose of the HBC is to help its members enjoy birding.
- 2.2 The second purpose is to educate its members and others about birds and bird watching.
- 2.3 The HBC may also engage in other activitiles designed to support the above purposes. These may include but are not limited to field trips and fund raising activities.
 - 2.4 No net income of the HBC shall materially benefit any individual.

Article III - MEMBERSHIP

- 3.1 Membership in the HBC shall be open to any person interested in the purposes of the HBC and who has paid the dues for the current year.
 - 3.2 There shall be three classes of membership as follows:
 - a) Individual single person
 - b) Family two or more persons of the same household
 - c) Supporting an individual or family member making a contribution at or above a minimum level determined by the Board of Directors of the HBC.

Article IV - DUES

- 4.1 Membership dues for the year September through August shall be set by the Board of Directors of the HBC.
 - 4.2 Dues will be payable in September of each year.
- 4.3 New members may join at any time. However, membership will be for the current membership year unless payment is made after the last meeting of the year.

Article V - BOARD OF DIRECTORS

- 5.1 The HBC shall be directed by a Board of Directors (hereafter called "the Board") composed of the following: President, Vice President/Program Director, Treasurer, Secretary, and three members at large, including the immediate past president (if possible).
- 5.2 Officers and Board members shall be elected for one-year terms and shall be eligible for re-election.

- 5.3 The responsibilities of the Board shall include, but not be limited to, the following:
 - a) Overseeing operation of the HBC.

b) Arranging of meeting times and locations, and calling of business meetings.

c) Appointing of people to organize and make arrangements for field trips, and publicity. This shall be done as soon as possible after the annual meeting.

d) Setting of dues and overseeing of the expenditure of the HBC's funds.

- e) Naming of any committees necessary or helpful to fulfilling the HBC's purposes.
 f) Appointing of temporary officers and other Board members to fill unexpired terms whenever a vacancy occurs.
- 5.4 In order to conduct official business, at least four members of the Board must be present.

Article VI - DUTIES AND RESPONSIBILITIES OF THE OFFICERS

- 6.1 The officers of the HBC shall be the President, the Vice-President/Program the Treasurer, and the Secretary.
- 6.2 The President shall preside at meeetings of the Board and all meetings of the HBC. The President shall also name, in consultation with the Board, a nominating committee at the appropriate time, and shall call meetings of the Board, as necessary.
- 6.3 The Vice-President/Program Director shall, in the absence of the President, assume the duties of the President. As Program Director, this officer shall be responsible for planning and arranging all monthly evening programs for the upcoming membership year.
- 6.4 The Treasurer shall handle all financial matters of the HBC, subject to the direction and supervision of the Board. This officer shall prepare an annual report and such interim reports as the Board may Request.
- 6.5 The Secretary shall be responsible for the maintenance of all official records of the HBC; shall keep minutes of all business meetings and Board meetings; maintain a current membership list; handle all correspondence; and mail notices of all regular and special meetings to the HBC membership.
 - 6.6 The above officers shall assume other duties as assigned by the Board of Directors.

Article VII - MEETINGS

- 7.1 Regular monthly program meetings of the HBC shall be held from September through June.
- 7.2 The annual meeting of the HBC shall be held in conjuction with the May program Meeting.
- 7.3 Other meetings of the HBC may be called by the Board.
- 7.4 All regular program meetings shall be open to the public.
- 7.5 All meetings of the HBC Board shall be open to any member of the HBC, however, only duly elected Board members shall have voting privilege.

Article VIII - FIELD TRIPS

- 8.1 As an important opportunity for members to observe new and interesting birds and their behavior, field trips shall be held periodically throughout the year.
- 8.2 All participants of field trips shall be required to sign a waiver of liability form prior to the beginning of a field trip.

Article IX - TRANSACTION OF BUSINESS AT PROGRAM MEETINGS

- 9.1 Business may be transacted at any monthly program meeting at which a quorum is present. A quorum is defined as fifteen percent of the current membership. All current members of the HBC shall be eligible to vote.
- 9.2 The Secretary shall mail notice for all business meetings to the membership at seven days prior to the meeting.

Article X- ELECTION OF OFFICERS

- 10.1 In consultation with the Board, the President shall appoint a nominating committee at the March program meeting each year. The nominating committee shall be composed of three members of the HBC. At least one member of this committee shall be a member of the Board and at least one shall be a person who is not on the Board, but from the membership at large. The nominating committee shall present a slate of officers, and other board members, to be voted on at the annual meeting in May. Nominations will also be accepted from the floor, if seconded.
- 10.2 Newly elected officers and board members shall assume their duties immediately after the annual meeting.
- 10.3 To be eligible for election to the Board, one must have been a member of the HBC for at least one calendar year prior to the election.
- 10.4 To be eligible for the presidency of the HBC, one must have served on the Board for at least one calendar year prior to the election.

Article XI- FISCAL YEAR

The fiscal year of the HBC shall commence June 1 and end May 31 of each year.

Article XII- AMENDMENTS TO THE BYLAWS

- 12.1 A vote to amend these bylaws may be taken at any regular program meeting, provided that the proposed changes were introduced at the previous regular monthly program meeting. A quorum must be present (Article IX) and a two-thirds majority of those present will be required to approve any change.
- 12.2 Proposed amendments may be introduced by any member of the HBC by presenting the proposed change, in writing, to the Board. The Board must discuss the proposal at its next meeting and present it, along with Board recommendations, to the HBC at the next monthly program meeting.

Article XIII- CESSATION OF OPERATIONS

When there have been no meetings or scheduled activities for a period of eight consecutive months, the HBC shall be considered dissoived. In that event, the Board shall be responsible for the liquidation of assets and the subsequent conveyance of those assets to a non-profit organization with similar purposes.

Dear Friends -

The Hampshire Bird Club is a group of people who enjoy watching birds, either as a casual hobby or to the point of an addiction. We are a good source of information for those just getting started or for those who would enjoy knowing more about the natural history of birds. Anyone interested in birding regardless of experience or level of expertise is welcome. We meet monthly, September through June, at the Hitchcock Center in Amherst to hear guest speakers, see slide presentations and review ecent sightings and experiences. The Club also sponsors field trips throughout the year and participates in the annual Christmas Count. Members we access to a lending library, a rare bird alert, and current birding information available through the Voice, an up-to-date recorded telephone service.

MONTHLY MEETINGS

Monthly meetings are held on the second Monday of each month (except October when it is the third Monday) at 7:30 p.m. (unless otherwise noted) at the Hitchcock Center in Amherst (always).

<u>Sept. 12. 6:00 p.m.</u> - POTLUCK PARTY! Come and greet old friends or meet us for the first time. Bring your Big Bird stories, your appetite, something to drink and food to share, enough for 8-10 people. As a guide, if your last name begins with A-L, bring a main dish; M-R, bring a salad; S-2, bring a dessert. (If you have a favorite dish in another category that you would prefer to bring, feel free to ignore this guide.) The Club will provide utensils, plates, napkins, cups and ice. Please note that the potluck is NOT A BARBECUE this year.

Oct. 12 - Roger Everett, professional naturalist/photographer will present a program entitled "Birds of Cape Cod." He has had his photos published in "Birder's World," "American Birds," "Wildlife Art News" and "Cape Cod Life." His new book Wading and Shorebirds has just been ablished.

On Nov. 14, Scott Surner will present a slide show entitled "Newfoundland - Land of Cod Tongue and Ptarmigan." And on Dec. 12 there will be a holiday party when members show their own slides and plans are made for the Annual Christmas Count. BIRD ALERT TELEPHONE TREE

Also enclosed is a Bird Alert form which gives you the opportunity to be on a telephone tree that notifies birders when rare birds are seen in the area and where to find them. Please read the information carefully - we hope that it will clearly indicate why we are changing the process this year. Deadline for signing up is <u>Friday</u>, <u>September 16</u>.

NURSING HOME PROJECT

HBC and the Hitchcock Center are co-sponsoring a bird feeder program for local nursing, convalescent and residential care facilities. It is a three part program that includes putting up feeders, presenting a slide show on feeder birds and having a follow up visit by our members to visit with the residents and to answer questions. Each facility will also receive a poster, a book and a chart on feeder birds. Last winter our pilot project in Hadley was a great success. We hope to have this program off and running this fall. Cape May Birds!



The days are getting shorter; birds and their watchers are heading south, many of both stopping at Cape May, New Jersey, renowned migration concentration area. For the past five years the species list on our third-weekend-of-September trip has gone well over 100, and our cumulative list stands at 179. More than numbers, we remember certain scenes—the morning it rained warblers, Black Skimmers skimming at sundown, the Merlin eating a Black-throated Green Warbler, dusk flights of thousands of herons and ibises into the Stone Harbor heronry, squealing flickers chased by Sharp-shinned Hawks . . .

The Hampshire Bird Club will sponsor the annual trip to Cape May and Brigantine National Wildlife Refuge this fall. It is open to bird-watchers of all abilities and will be led by Tod Highsmith and David Spector. Our schedule--subject to the vagaries of birds and weather--will be roughly as follows:

Friday, September 16 -- meet and camp.

Saturday, September 17--Warblers and other land birds at the camp and Higbee's Beach; shorebirds at the South Cape May Meadows; lunch, hawks, and other birds at Cape May Point; salt marsh and the Stone Harbor Heronry at sunset; and dinner at camp.


Sunday, September 18--Cape May area in the early morning; shorebirds, lunch, ducks, and other birds at Brigantine refuge; and return to Amherst Sunday evening.

The group will camp in Cape May; participants need their own sleeping bag and tent or camper; please inform a leader if you can accomodate extra sleepers or need space in a tent. There are many hotels in the Cape May area; early reservations are suggested for those who prefer not to camp. The trip costs \$30 for members of the Hampshire Bird Club. The price for non-members is \$40. (A note to the thrifty--club memberships start at \$7.) The fee includes the campsite, breakfast and lunch on Saturday and Sunday, and Saturday dinner (nothing fancy!). We will arrange carpooling from Amherst.

MEETINGS

Monday. October 17. 7:30 p.m.: A very special program is planned featuring the well known bird photographer Roger Everett who will speak on the Birds of Cape Cod. A serious photographer since 1972, he began concentrating on birds in 1977. The thrill and joy of pursuing the challenge of portraying bird life on film has been all-consuming ever since. After taking early retirement from his job as financial controller for Texas Instruments in Attleboro, MA, he moved to Brewster on Cape Cod to take up bird photography full time. Everett is a member of the Photographic Society of America where he holds a star rating in pictorial color slides. His photos have been published in Wildlife Art News, Birder's World, American Birds, Bird Observer, and Cape Cod Life. A recent book of Everett's pictures, Wading and Shore Birds has been published by Schiffer Publishing. is also in demand as a speaker, sharing his slides with the public, and is a regular exhibitor at art shows.

FIELD TRIP POLICY

- 1. Field trips are an essential activity of the Hampshire Bird Club providing an important means of increasing members' interest in and knowledge of birds and birding.
- 2. Field trips are open to all members of the HBC who have completed a *Release of all Demands Hold Harmless* form for the current membership year. Non-members are also welcome to participate on a space-available basis, upon completion of release form.
- 3. The HBC conducts two different types of field trips, regular and fee-based.

Regular field trips will generally be less formal and will not require extensive planning by the trip leader. No costs other than travel, meals, and incidental fees will be involved. Participants must call trip leader in advance to express interest in the trip in order to allow for more flexibility and opportunity to change the trip itinerary should that seem desirable.

Fee-based trips are those for which participants must pay in advance for predetermined costs. Such trips will generally require more planning by the trip leader, including, for example, the making of reservations for lodging and boat transportation when needed. Participants will be charged an amount equal to actual predetermined costs plus a prorated amount to cover the reimbursement of the leader's expenses as stated in Item 6, below. Participants who are not members of the HBC will be charged an additional ten dollars (\$10). All fees shall be paid to the HBC Treasurer. Prepaid fees will be refunded, if feasible, whenever participation is cancelled due to extenuating circumstances. Any excess fees remaining after costs have been met, unless greater than ten dollars per person, will revert to the HBC treasury.

- 4. It is recommended that automobile transportation costs for both regular and fee-based field trips be set at a minimum of fifteen cents per mile (\$.15/mi.) per car plus tolls and parking fees. All persons in the car will be expected to share costs equally.
- 5. Leaders of fee-based trips shall:
 - a. Describe in writing the nature of the trip as completely as possible including the conditions of lodging, extra costs not covered by fee, the roughness of terrain, etc., and provide a list of what each participant should take on the trip.
 - b. Upon return, provide the HBC Board with an itemized account of all income and expenses related to the trip including receipts for major expenses.
- 6. Leaders of fee-based trips shall be reimbursed for all predetermined trip costs and incidental costs incurred in planning and arrangement (telephone, postage, etc.) and shall be given a per diem/honorarium of forty dollars (\$40) to cover meals and minor incidental costs. With regard to auto transportation costs the leader will be considered a participant and expected to share the costs as described in Item 4, above.
- 7. Leaders of all trips shall submit a list of birds identified on the trip to the HBC president who shall maintain the club's year and life lists.

THE BASICS OF BIRDING (Winter course offered by the Hitchcock Center, Amherst)

Watching birds. Birding is as simple as that. And winter birding is the perfect time to leisurely watch and enjoy resident and wintering species.

This eight week class, taught by Jan Ortiz, is designed for the beginning birder and for those who want to brush up on their birding skills. Among the topics to be covered will be the selection and use of binoculars and field guides. A primary goal is that the class participant become quite familiar with the common species in our area, and as we observe these birds at the feeder and in the field, we will discuss their behavior, natural history and identification.

The class will meet on Saturday mornings from 7 a.m. until noon. Half of the morning will be spent in the warmth of the Hitchcock Center watching birds at the Center's feeders and talking about various aspects of birding. For the second half of the class, we will go out into the field and search for, among others, wintering hawks, owls and finches.

There will be two guest speakers: David Spector on "How to Identify and Misidentify a Bird, and Mark Mc Garigal on "Owls: Their Natural History and Identification." (This includes an optional "Owl Prowl" in the wee hours of the morning to look for Screech, Barred and Great-horned owls.)

DATES: Saturdays on January 14, 21, & 28; on February 4, 11, 18 & 25; and on March 4.

TIME: 7 a.m. until noon.

PLACE: Classes will meet at the Hitchcock Center. Field trips

will be local.

COST: Hitchcock members \$45.00. Non (Hitchcock) members \$55.00.
